

Aetna Screening Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Aetna Screening Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia, but excluding residents of the following states: Kansas, Massachusetts, Missouri, Montana, New Jersey, New Mexico, New York, and Vermont. Entrants must be at least eighteen (18) years old at the time of entry. Employees of Aetna or any other CVS Health company as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules. Sponsor's and Administrator's decisions are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

3. Timing: The Sweepstakes begins on April 1, 2020 at 12:00 a.m. Eastern Time ("ET"), ends on June 30, 2020 at 11:59 p.m. ET (the "Promotion Period"), and consists of three (3) Monthly Entry Periods as set forth in the chart below. Sponsor's computer is the official time-keeping device for the Sweepstakes.

4. How to Enter: Consumers can enter by either method:

a. Enter By Completing the Online Health Screening (only available to Aetna Commercial, Student Health, International (US expats) and Resources for Living members): Log into your Aetna online account and follow the links and instructions to completed the Emotional Well Being Screening. Upon completion of the screening you may opt in to this Sweepstakes by clicking the "Enter Sweepstakes" button and you automatically will receive one (1) entry into the Monthly Entry Period drawing associated with the time and date you completed the assessment as well as the Grand Prize drawing.

b. Enter By Mail: Hand print your name, address, email address, and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "Aetna Screening Sweepstakes," c/o Merkle Inc., P.O. Box 5031, Department 838961, Kalamazoo, MI 49003-5031. You will receive one (1) entry into the Monthly Entry Period drawing associated with the date of your mail in entry as well as the Grand Prize drawing. Limit: One (1) entry. All mail-in entries must be handwritten and must be postmarked by the dates listed in the chart above and received seven days after the applicable dates. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Limit: You may receive one (1) entry during the 2020 calendar year, regardless of the number of times that you complete the behavioral health assessment. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than one (1) entry by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that

entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being an authorized account holder.

5. Prize Drawings: Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. Administrator will randomly select the potential Sweepstakes winners for each Monthly Entry Period drawing from all eligible entries received during each applicable Monthly entry Period on or around the dates listed in the chart in Section 3. Administrator will randomly select a Grand Prize winner from all entries received during the Promotion Period on or around July 20, 2020. All potential winners will be notified by email from the Sponsor after the drawings. *Due to current restrictions on non-essential businesses, the processing of mail-in entries may be delayed, and this may postpone the date of the drawings.* If a potential winner of any prize cannot be contacted, or the prize is returned as undeliverable, the potential winner forfeits the prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a/the potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded. Prizes will be fulfilled within approximately 8-10 weeks after each drawing but may be delayed if the drawings are delayed.

6. Prizes: ONE (1) GRAND PRIZE: A \$500 Aetna e-gift credit that can be redeemed for \$500 in retail gift cards. Approximate Retail Value ("ARV"): \$500.

THIRTY (30) MONTHLY ENTRY PERIOD PRIZES (Ten (10) awarded each Monthly Entry Period): A \$50 Aetna e-gift credit that can be redeemed for \$50 in retail gift cards. ARV of each prize: \$50.

Winners will have the option to select from list of retailers provided by Aetna and may opt to receive multiple gift cards. Terms and conditions of each gift card applies. Prize will be fulfilled as a unique digital link. Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Winners are responsible for all taxes and fees associated with prize receipt and/or use.

7. Release: By receipt of any prize, winners agree to release and hold harmless Sponsor, Administrator, and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of any prize.

8. Publicity: Except where prohibited, participation in the Sweepstakes constitutes each winner's consent to Employer, Sponsor's and their agents' use of winner's name, likeness, and/or photograph for promotional purposes in any media, worldwide, without further payment or consideration.

9. General Conditions: Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures, human error or any other factor impairs the integrity or proper functioning of the Sweepstakes, or any event or cause beyond Sponsor's control (e.g. events such as natural calamities, national emergencies, wide spread illnesses, declarations of war, acts of God, acts of terrorism) interferes with any aspect of the Sweepstakes, including but not limited to fulfillment of the prize(s), as determined by Sponsor in its sole discretion. In such event, Sponsor, in its sole discretion, may elect to modify the prizes offered herein and/or hold a random drawing from among all eligible entries received up to the date of discontinuance for applicable prizes offered herein. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or

the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Sweepstakes, if it is possible. Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Drawing or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Drawing, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
